Notes:

- All Routes Start and End at the Yellow & Brown Parking Lots on Central Ave in the morning. In the evening the Main Line starts at the Yellow Lot and the Uptown Route starts at 235 Peachtree St. **Chauffeurs MUST Contact Dispatch From The Parking Lot At End Of Their Shift PRIOR TO BEING RELEASED.** Chauffeurs must complete a Daily Passenger Report with the times and number of passengers picked up from each location. Chauffeurs must always look for passengers waiting to board.

Pax: Fulton County Main Route

-Starting at 10:00am, the mid-day bus will make stops at all of the Fulton County Properties listed. Expected departures from the Parking Lots are every 30 minutes.

-From 11:00am - 1:00pm jurors typically get released and take priority over requests and the rest of the Route. No other passengers will be picked up until after all Jurors have been picked up and dropped off.

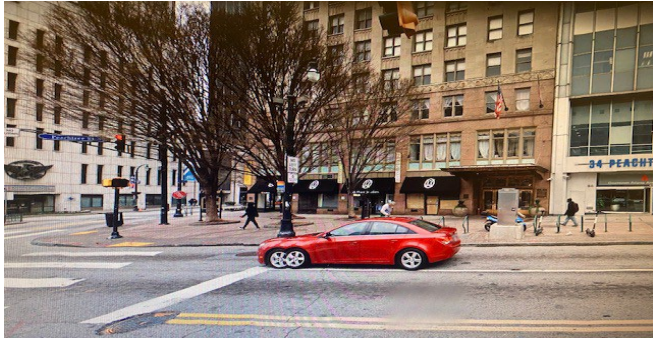

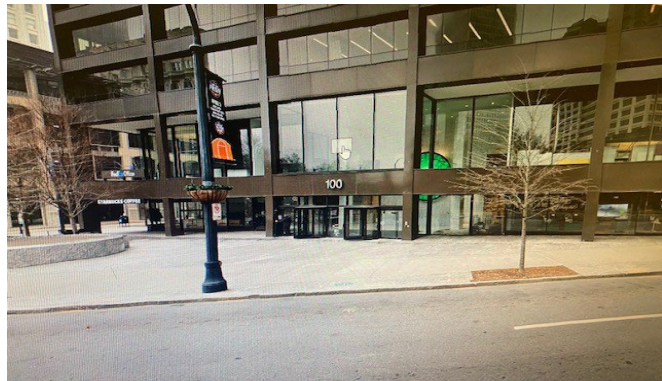

Turn Right onto Williams St

Turn Right onto Peachtree St NW

Stop – 100 Peachtree St. NW, Atlanta, GA (Drop at Corner of Auburn Ave)

Turn Left onto Auburn Ave NE

Turn Right onto Park Place NE

Stop - 10 Park Place NE, Atlanta, GA (Drop at Corner of Edgewood Ave)

Turn Left onto Wall St

Turn Left onto Peachtree Center Ave. NE

Turn Left onto Andrew Young Int. Blvd. NE

Stop – 235 Peachtree St. NE, Atlanta, GA., 30303

(The Mall at Peachtree Center Entrance on Andrew Young Int. Blvd. NE At 18 Andrew Young Intl Blvd NE.)

Turn left onto Peachtree St. NE.

Turn Right onto Pryor St. SW.

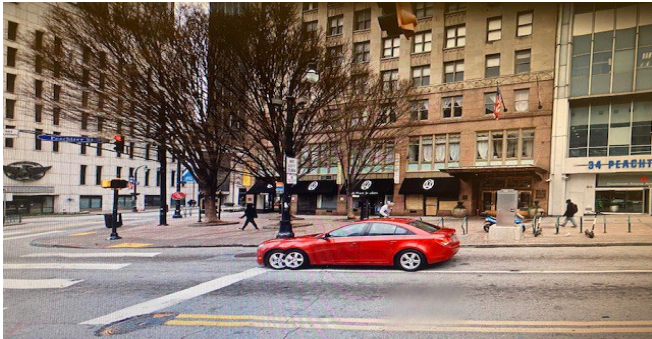

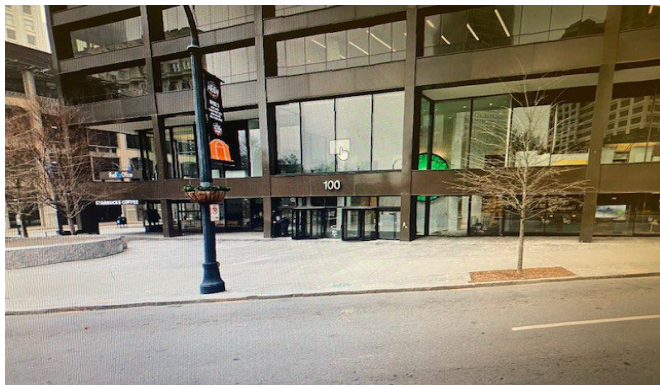

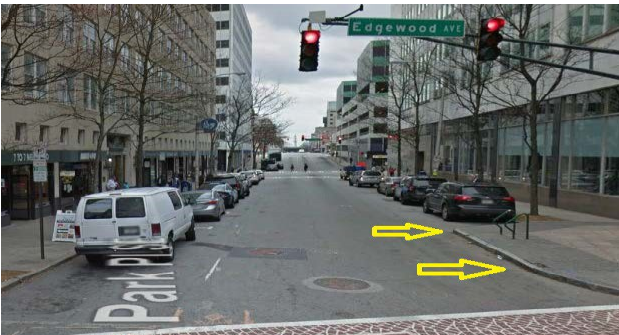

Head SW on Pryor St. SW

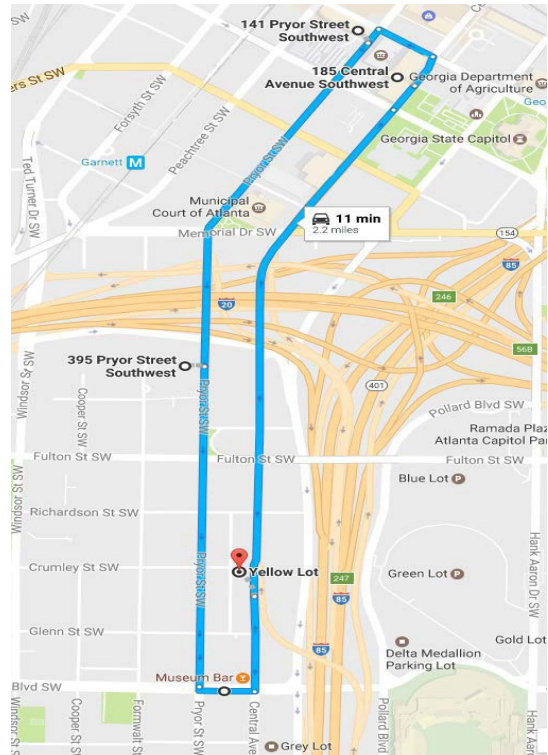

Return to Yellow Lot



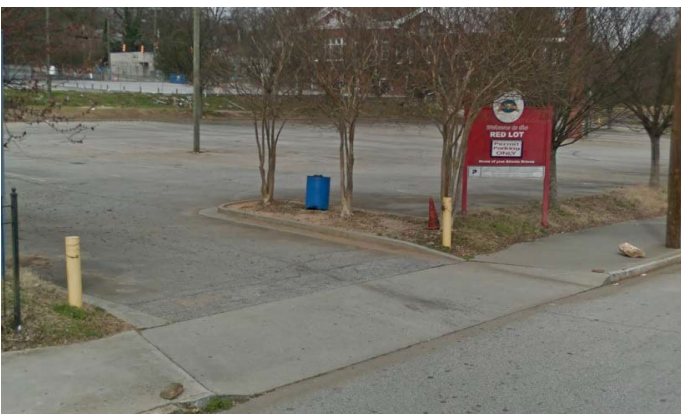
Yellow Lot - 593 Central Ave, Atlanta, GA



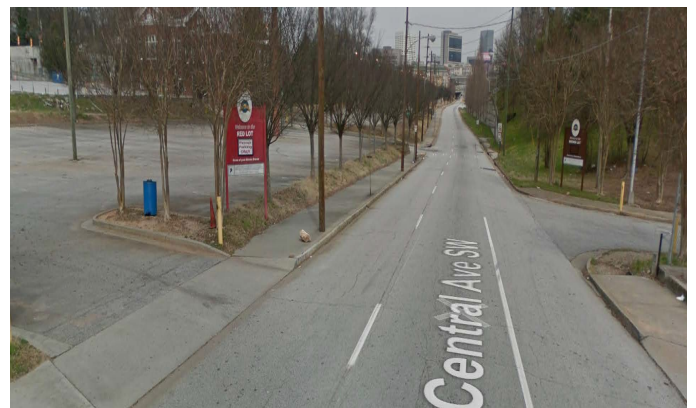
Brown Lot - 630 Central Ave, Atlanta, GA



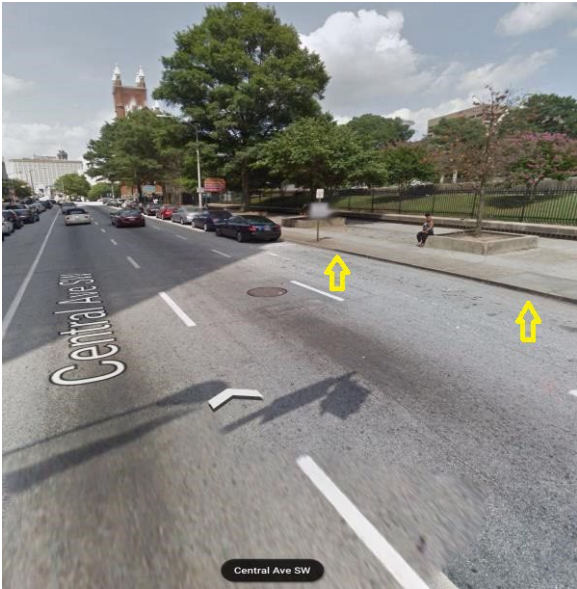
Red Lot - 631 Central Ave, Atlanta GA

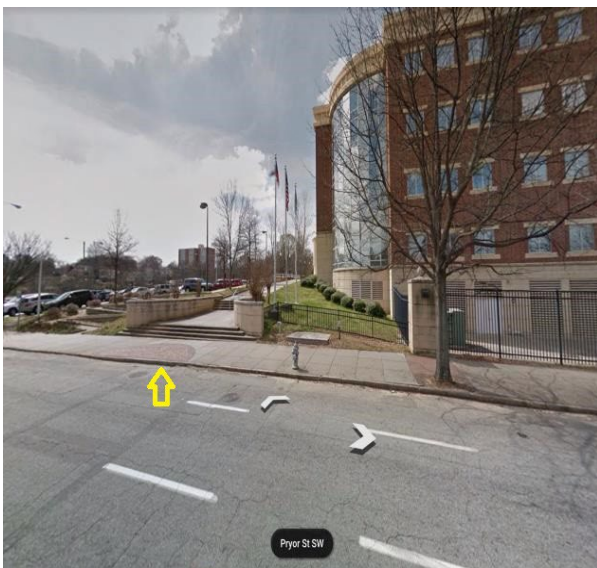

Turn left onto Pryor St SW

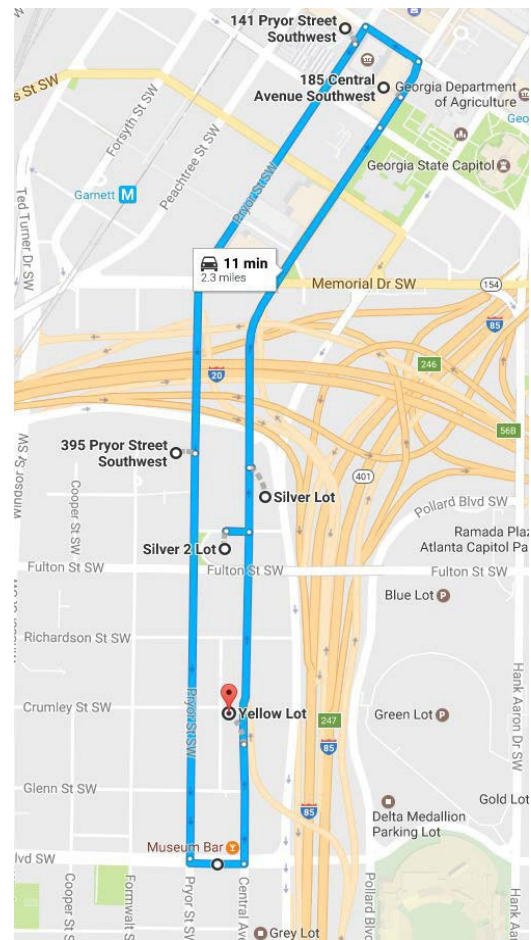
Stop – 141 Pryor St SW, Atl, GA, 30303 (In front of Fulton Cty, Government Ctr.)

Head South on Pryor St SW

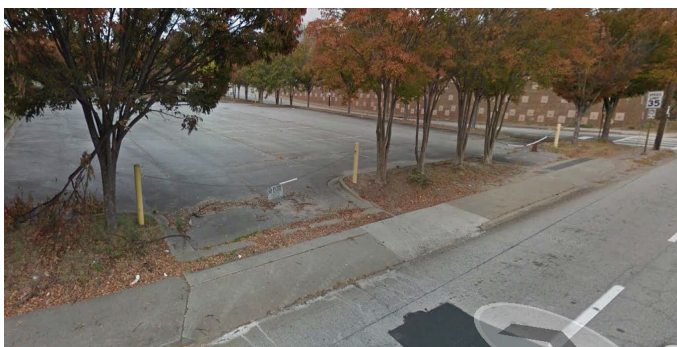
